IPNIG Strategic Plan of Action 2012 - 2014

- 1. To guide in the development and implementation of quality professional nursing practice standards
- 2. To strengthen the professional recognition of registered nurses in independent practice within the community health care system
- 3. To increase public awareness and build partnerships for the business operation and equitable recognition for services rendered by nurses working in independent practice
- 4. To provide resources for learning the necessary business skills, marketing strategies and operation guidelines for a business
- 5. To create educational opportunities and funding resources

IPNIG for the first quarter 2012 concentrated on their plan for member's education [as above]

- To provide resources for learning the necessary business skills, marketing strategies and operation guidelines for a business
- To create educational opportunities and funding resources

IPNIG promoted two education workshops for their members. What is significant is the two Interest Groups co sponsored the cost of the workshop resulting in reduction of costs to one half to each Interest Group. In addition IPNIG and OHNIG "took the show on the road" when invited to Windsor Essex RNAO Chapter to present the workshop. Again a significant savings by sharing costs three way.

On March 31st 2012 The IPNIG co sponsored an education workshop for the Windsor Essex RNAO Chapter. The workshop titled "Pearls and Perils" provided case studies of successful registered nurses in independent practice plus presentations from two business experts on the pros and cons of operating their own business and funding resources available. IPNIG plans in the future to offer to take this workshop to other locations.

On Saturday April 28th the IPNIG and OHNIG co share costs for the IG breakfast meeting the day following the RNAO AGM. The presentation includes a motivational speaker "Accelerating Your Career" and business experts describing the "Nuts and Bolts" of business start up. The co – sponsoring and savings in turn allow IPING to offer the education at a no cost basis to their members,

IPNIG members who have attended workshops have shared their feelings: "well worth attending," and "need more in depth understanding in order to proceed on my own in business" and others say "having business experts present the necessary skills very valuable". These workshops let members gain immensely from "Networking" and learning by talking one-on-one to the presenters, to each other and from successful career registered nurses in their own business.
